The following **Inspectors of Income Tax** are hereby promoted and appointed to officiate temporarily to the grade of **Income Tax Officer (Group-B Gazetted)** purely on **ad-hoc basis**, in the Level-8 of Pay Matrix, Rs. 47600-151100 (as per 7th CPC) plus allowances (as admissible) **with immediate effect or the date they assumes charge, whichever is later**. These promotions are being effected on **in-situ basis** and the officers will continue to discharge the same functions and duties as they were discharging before their promotions, until further orders :-

2. The **ad-hoc appointments** are made for a period of **one year (i.e. upto 10/05/2023)** or till these officers are appointed on regular basis, whichever is earlier. These appointments are intended to be purely on ad-hoc nature subject to the following conditions :-


- Such appointments shall not confer any right to the Officers for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoPT as contained in OM NO. 28036/8/87-Estt(D) dated 30.03.1988 and instructions issued by Government from time to time.
- These appointments will not confer any right or equity in favour of the appointees.

3. This promotion order is issued purely on temporary basis and an officer is liable for reversion at any time without assigning any reasons, if after a review of vacancies it is found that his/her appointment is in excess of the vacancies available OR for any other reasons, including directions of any Court/CBDD/DoPT etc.

4. The promotion of the officer(s)/official(s) shall be subject to revision of the seniority, if any, consequent to directions issued by CBDD in N.R. Parmar case vide letter dated 27/05/2019 & directions issued by CBDD in K. Meghachandra Singh case vide letter dated 26/10/2021 read with DOPT's OM dated 13/08/2021 and other similar cases on matter pending, if any, in various courts (Supreme Court/High Court/CAT etc.).

5. The promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter related to SLP(C) No.30621/2011 and 31288/2017 & orders of litigations pending in various courts and further instructions of DOPT and/or CBDD in this regard.

6. The seniority of the officer(s) will be fixed as per the rules prevailing on the subject.
7. The fixation of pay of the above official(s) in the promoted cadre shall be made with reference to the CCS(Revised Pay) Rules applicable. The fixation of pay in the case of official(s) who have been granted Financial Upgradation in the relevant pay scale under the ACP/MACP Scheme which is equivalent to the cadre of **Income Tax Officer**, vide this office orders shall be made in accordance to the clause 4 of Annexure-I of the MACP OM. No. 35034/3/2008-Estt.(D) dated 19th May, 2009 read with clarifications issued by DOPT and Board from time to time wherein the financial benefit allowed under ACP/MACP Scheme shall become final and no pay fixation benefit accrue at the time of promotion i.e. posting against a financial post in the higher grade.
8. The officers are promoted on ad-hoc basis. The services rendered as Income Tax Officer (Ad-hoc) shall not be counted towards 4 years of regular service as Income Tax Officer, for grant of higher level of pay(Level-9) corresponding to the pre-revised grade pay of Rs. 5400/- as per CBDT's clarification dated 14/09/2009.
9. The promotee(s) concerned are directed to join on promotion as **Income Tax Officer** at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of **Income Tax Officer**, directly to this office within one month from the date of this order positively, otherwise action will be taken as per extant rules.
10. The promoted official(s) will be liable for transfer as per transfer policy and/or on account of administrative requirements. The transfer & posting order will be issued separately.
11. The Head of Office(s) concerned will send a report intimating the date of reporting of the officer(s)/official(s) in the promoted cadre, to this office.
12. This issues with the approval of Pr.CCIT, Bengaluru.
